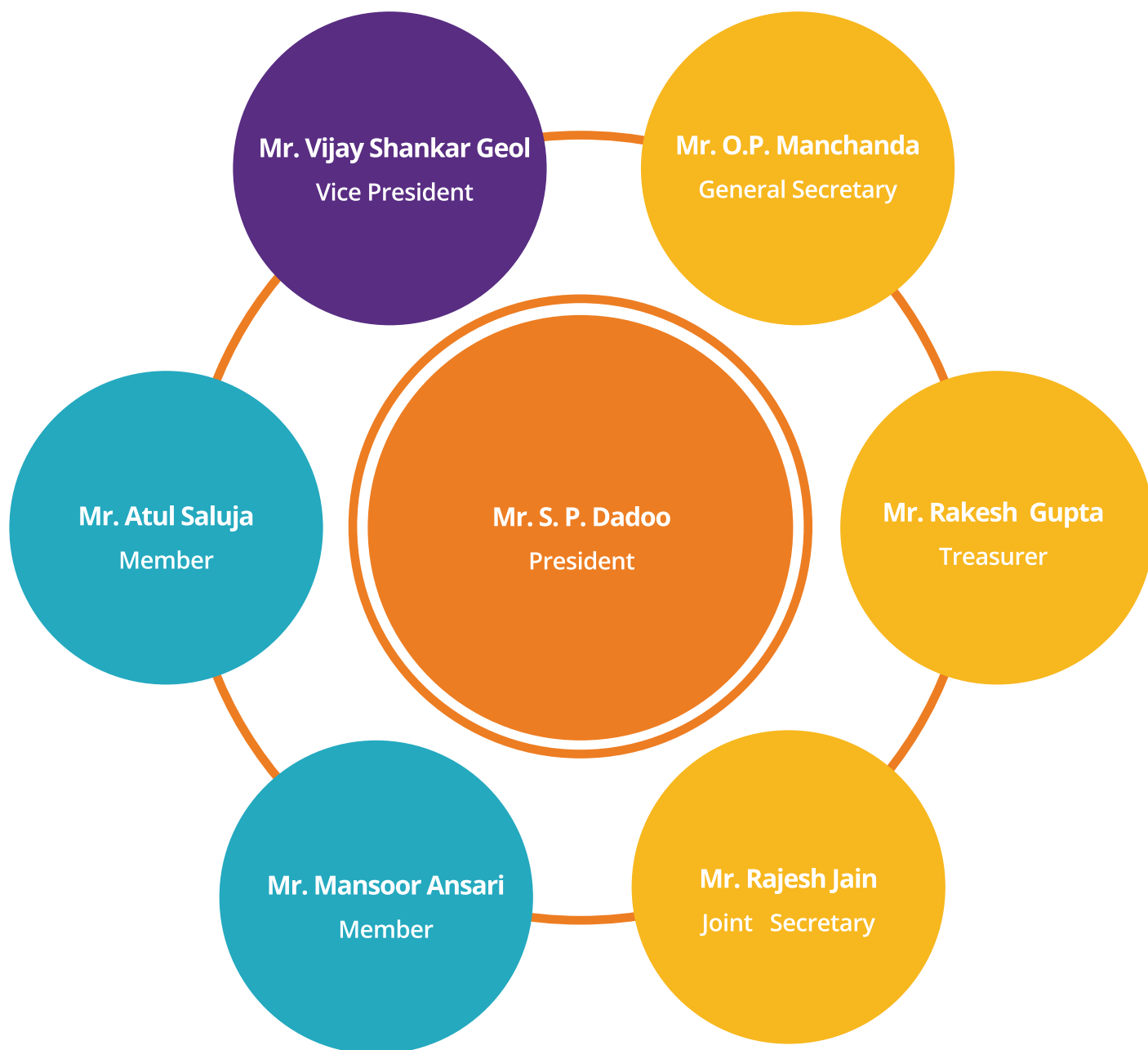

MOBILE EDUCATION (VAN)



On the occasion of 70th Independence Day at slum cluster of sector 9 & 10 Noida, the Mobile Education Van, initiative of Gautam Buddha Society for social welfare, was dedicated to the district of Gautam Buddha Nagar in the presence of Shri N P Singh, IAS District Magistrate, Shri Vineet Kumar ADM, Shri Makhanlal Gupta CDO and prominent persons Shri Rakesh Kumar, Chairman IEML; Shri D Kumar; Shri S.P. Dadoo; Shri Tanveer Ahmed; Shri Atul Saluja; Smt. Sindhu Ravi, CEO Niveda Foundation; Mr. Naresh Kumar from Wipro and other members of the welfare society.



The education Van has been equipped with Audio Visual systems, Water dispenser, stationary and White board and other necessities of a class room. National Book Trust had donated books for the Mobile van. 150 children have been enrolled till now and a Doctor volunteer runs a medical checkup on all of them. Food supplements are provided to the children.



INTRODUCTION

ABOUT INITIAL WORK OF THE SOCIETY IN VILLAGES AND SECTORS

EDUCATION CENTRE AT KASNA VILLAGE, GREATER NOIDA

KASNA is a popular village in Greater Noida, UP and has a population of around more than Fifty thousand people comprising of approximately Two thousand children. There are only around 5-8 organized /unorganized education centres to educate the children. However, the quality of education remains a question mark.

Kasna is a village where most of the families have migrated from West Bengal, Bihar, Uttaranchal, Orissa etc. They live on rent in the jhuggis of Kasna. The basic occupation of the people are rickshaw pullers, vegetable sellers, labour working on daily wages, hawkers etc.

Thus, the Gautama Budha Society For Social Welfare, with help of it's resources able to identify a location, and mobilized and identified 50 non-school going children, and started the Early Learning Centre. GBSFSW had done number works for the centre and managing all requirements of the education centre.

SECTOR-10, NOIDA

In Sector – 10 Noida, Industries are present where the surrounding population of these industries consist of factory workers, labours, rickshaw pullers and daily wage workers. As a result, many small children are found as rag pickers and labours working on daily wages because of lack of awareness about education.

Therefore, Gautama Budha Society came with an initiative to help the underprivileged children to get their identity by providing them education and better way of living. This is an initiative to mobilise the non-school going children and mainstream them to formal schooling. Children enrolled with education centre are enjoying the education and other activities for there overall development.

SECTOR-17, NOIDA

Sector 17 Noida, J J Colony is an area which is a core slum belt. Mostly people living here are migrants from Bihar, West Bengal and Orissa. Many small children were found as rag pickers because in this sector there is not any Government or Private or NGO Schools.

Therefore, Gautama Budha Society came with an initiative to help underprivileged children to get their identity and start with their basic Education. This is an initiative to mobilise the non-school going children and mainstream them to formal schooling.

To provide these students all such facilities and quality education with the limited resources available, for the complete development of these students and to mativate them and to create a confidence amongst these students in all respect.

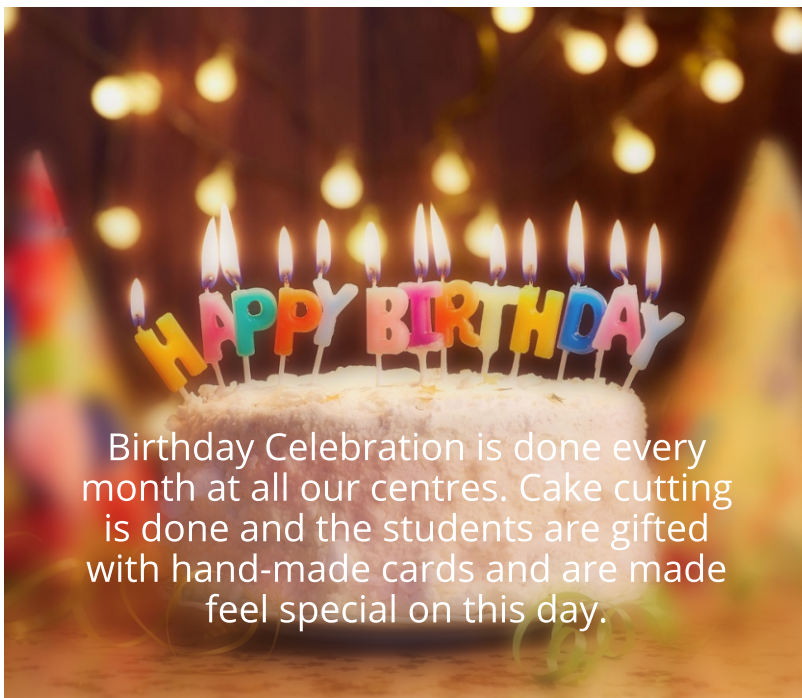

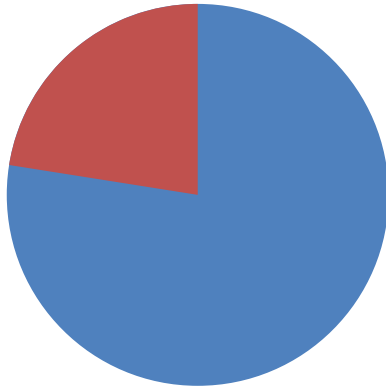

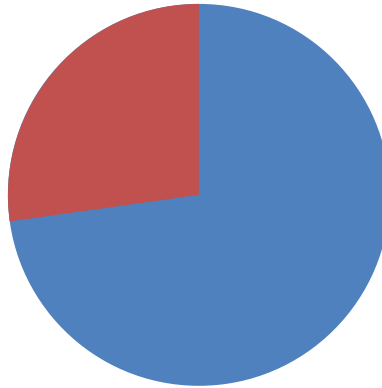

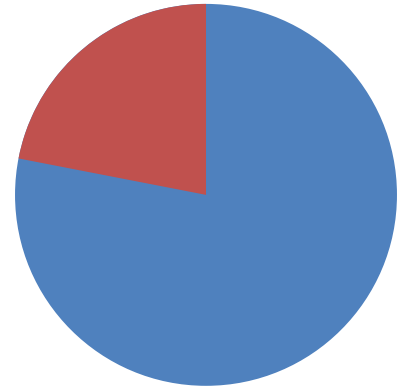

A. ABOUT US

The Trust has been incorporated on 30/04/2016 with Registrar of Societies vide Registration no. - 105. The registration is valid till 29/04/2021. The deed registered under Societies Registration Act of 1860.

The Trust has been granted Order for registration under section 12AA of the Income Tax Act, 1961 VIDE Order No. ITBA/EXM/S/12AA/2017-18/1008031508(1) on 22/12/2017. Hereby granted registration with salient activities as Relief on the poor and the provisions sections 11 and 12 shall apply in the case from the Assessment Year: 2017-18.

Subsequently vide Order under section 154 of the Income Tax Act, 1961 dated 07.02.2018 the above said exemption is valid from assessment year 2018-19 till it is rescinded.

The Trust has been granted approval under section 80G(5)(vi) of the Income Tax Act, 1961 on 18/05/2018. The exemption is valid from assessment year 2018-19 till it is rescinded.

B. BASIS FOR PREPARATION OF FINANCIAL STATEMENT

The Accounts have been prepared in accordance with the historical cost convention, generally accepted accounting principles in India.

C. FIXED ASSETS

- a) Fixed assets are stated at historical cost inclusive of inward freight, duties and taxes and incidental expenses related to acquisition.
- b) Asset valuing upto Rs. 5,000/- excluding furniture, fixture and wooden crates are charged to revenue in the year of its purchase.

D. DEPRECIATION

- i. Depreciation on all fixed assets are provided in accordance with schedule II of the Companies Act, 2013 on written down value method.
- ii. Depreciation is charged @100% in case of assets valuing upto INR 5000/- in the year purchase.
- iii. Assets obtained under donation has been retained @ Re 1/- for each such asset.

E. REVENUE RECOGNITION

- i. Subscription from members (enrolled as member upto the year end) are accounted for on accrual basis.
- ii. Interest on fixed deposits is being accounted on accrual basis.
- iii. Other incomes are recognized only on the receipt of the same during the year.

F. The Trustees have not drawn any remuneration from the Trust since the inception of the Trust.

G. REVENUE AND EXPENDITURE IN FOREIGN CURRENCY

H. CONTINGENCIES
